

Long-Term Insights Briefing: Public Consultation Document

Staying ahead of the curve – Responding to emerging trends in detecting fraud and corruption in New Zealand
9 August 2024

Background

The Serious Fraud Office (SFO) is the lead law enforcement agency charged with investigating and prosecuting serious or complex financial crime including bribery and corruption. The SFO also leads fraud prevention efforts in New Zealand's public sector and works to strengthen the sector's resilience to fraud and corruption through its Counter Fraud Centre - Tauārai Hara Tāware.

We are seeking public feedback on the proposed topic for our next Long-Term Insights Briefing (Briefing).

The Public Service Act 2020 requires agencies publish a Briefing at least once every three years. These Briefings are prepared independently of Ministers, and are designed to:

- Provide information about long term trends, risks and opportunities that may affect New Zealand.
- Provide impartial analysis including policy options for the matters raised in the Briefing.

In producing a Briefing, agencies are required to consult with the public, ensuring that the topic explores a problem affecting New Zealanders and contains useful information to inform public opinion, academic research, and potential policy initiatives.

Why this topic?

Fraud, both global and domestic has increased significantly since 2020 and shows no sign of reducing to pre-pandemic levels. This is true for New Zealand, where it has become the nation's most commonly experienced crime type.

Fraud and corruption impact public trust in key institutions from government agencies to banks and decreases a nation's reputation as a safe place to engage in business.

Rapid technological change across fields like artificial intelligence has created new opportunities for fraudsters, but also provide advanced counter measures to thwart them.

What issues will we explore?

This paper will take stock of how we detect fraud and corruption, assessing international best practice and possible futures to help ensure New Zealand stays one step ahead of those who mean us harm.
